



## NWMCWC 100 Club

### Rules:

1. All entrants must be full, associate or junior members of NWMCWC .
2. The cost per year will be £12.00 payable by Standing Order ONLY. Complete the Standing Order form and send to your bank. Payments are to be received on the 23<sup>rd</sup> November annually.
3. Draws will be made quarterly at public events.
4. The prize fund will be 50% of the takings distributed between 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> & 4<sup>th</sup> place e.g. if all 100 numbers are sold takings will be £1200, therefore prize fund will be £600 divided between 4 draws making 1<sup>st</sup> prize £100, 2<sup>nd</sup> £25, 3<sup>rd</sup> £15, 4<sup>th</sup> £10. If all numbers are not taken the prize fund will be adjusted accordingly.
5. The purpose of the draw is to raise funds for the general running of NWMCWC.
6. A Gift Aid form is attached below the Standing Order for those who wish their annual donation to be treated as 'Gift Aid'. This should be detached and sent to the address given or handed in with your statement of agreement to the 100 Club Rules.
7. Numbers will be allocated in order of purchase. And then re allocated if anyone drops out over the years.
8. A record of names & numbers will be kept in the NWMCWC office.
9. Should you wish to cancel at anytime it is your responsibility to inform your bank to stop the Standing Order. It would be appreciated if you can also inform NWMCWC so that we can re sell the number.
10. NWMCWC will not be responsible for any bank charges incurred by you in the administration of your Standing Order. It is your responsibility to ensure that you have funds available when the Standing Order falls due.
11. NWMCWC reserves the right to cancel the 100 Club if considered appropriate or if fundraising is no longer necessary. All members will be informed in time to cancel their Standing Order.

13. Prize winners will be informed as soon as possible after the quarterly draws by telephone or email where possible. A list of winners will be posted locally and on NWMCWC website.
