3. Matters Arising:

- 4. Minutes of Board meetings 23rd March 2021 all had read, no questions so approved and signed off.
- 5. Finance It was agreed that there would be a specific finance meeting arranged for Tuesday 27th April, with JC.
- **6. Woodfuels AP** and Andy Mayo met with **JC** to go over the trade co accounts. **AP** is working with Paul and Stewart re working practices, H&S and so on. Prices will increase wef 1st May, 2021. PCC price increase still under discussion.
- 7. Ulva WR circulated her update prior to the meeting all had read.

Updates following report: Ecology BS paperwork circulated, Board need to read and approve content. Will need 2 signatories – Board agree that as they are already our bank signatories, **CM** and **TE** will sign on Board's behalf. The pre-start meeting with TSL has been delayed – have advised that they have to increase their quote due to covid. Board need to approve the increase before formally accepting. **WR** advised there is money in the projects contingency plan to cover this, and she will also apply to the Quaker Housing Trust in August. Board agree to using the contingency pot for this increase, but need to look at ways to raise funds to replenish the pot. **LP** is setting up regular meetings with the funders.

WR confirms fencers are due to finish this week and we can then submit the AECS claim.

Ferry is having its 3 year inspection this weekend and will then operate M-F, with Sundays from June. Boathouse due to open 26th April.

Treestory are finalising their plan and will have a final site visit soon before submitting the grant application. Looking for a public meeting of some sort in June/July to advise of plans.

TE confirms the replant is not eligible for carbon offset as it's a replant not new planting
